



MEMORANDUM

Whereas, Sh. Joginder Kumar, Junior Engineer (Civil) while posted in HPPWD Divn. Nalagarh was transferred to MC Shimla vice Sh. Rajender Kumar, Junior Engineer (Civil) and vice versa vide office order No. PWE-8-E (JE's Transfer)/ESIII-8269-73 dated 21.11.2020 on the approval of competent authority. Feeling aggrieved against this order, Sh. Joginder Kumar, Junior Engineer (Civil) filed CWP No. 5408 of 2020 before the Hon'ble High Court which was disposed of with the following direction:-

" Given the clause 5.5. of the comprehensive Guiding Principles-2013, of the transfer policy applicable in the State of Himachal Pradesh, which provides that an employee, who has less than two years to retire, should be posted in the convenient places/ stations, we dispose of this writ petition with liberty to the petitioner to make representation to the first respondent, within two weeks time for suitable adjustment, strictly in accordance with the transfer policy. On receipt of such representation, the said respondent shall decide the same, in the light of the transfer policy occupying the field, within two weeks. Subject to filing of representation within the time-frame mentioned above, the impugned order dated 21.11.2020, Annexure P-3 shall remain stayed. The petitioner is at liberty to approach this Court again, in case he still feels aggrieved and dissatisfied from the outcome of the representation. Pending application (s), if any, are closed."

And whereas, in compliance to direction passed by Hon'ble High Court, the petitioner made representation addressed to the Principal Secretary (PW) to the Govt. of HP Shimla-2 vide representation dated 4.12.2020. The applicant was given opportunity of personal hearing vide letter dated 31.12.2020, hearing fixed for 08.01.2021 but petitioner could not attend the hearing on scheduled date as he was deputed on Election duty. 2nd opportunity was offered to him vide letter dated 27.01.2020 i.e. after completion of election process and hearing fixed for 30.01.2021. On this date, the petitioner appeared in person and made his oral as well written submission to cancel his order as he is at the verge of retirement and remained only 11 months of service.
