Regarding Discrepancy in pay fixation in the Revised pay Rules.

It has been observed that there are certain discrepancies in the fixation of pay in the Revised pay Rules, 2022. There are cases where benefit of 4/9/14 years under Assured Career Progression Scheme has been allowed in the revised pay scales and in some cases 4/9/14 years benefit has been allowed not keeping in view the notification of Finance department dated 07.07.2014 which provides that the benefit of 4/9/14 under ACPS will be allowed only in those cases where the incumbent has not availed three financial up gradations/enhancements in their entire service career from entry level. The instructions dated 09.09.2014 also provides that cases pending for ACPS on 07.07.2014 shall also be viewed in light of instructions ibid.

In view of the above, you are hereby directed to review all such cases of pay fixation in the Revised Pay Rules, 2022 under your control and it may be ensured that no 4/9/14 benefit is admissible in the revised pay Rules except the ACPS which has been granted prior to the notification of Revised pay Rules that too after conducting DPC and entries of which exist in the service book. In case the pay has been fixed, the same may be immediately revised and recovery of the over payment may be effected from the concerned immediately under intimation to this office.

Regarding Clarification in respect of Assured Career Progression Scheme (ACP) to the Junior Engineer


It is informed that the matter regarding Carrier Progression Scheme to the Junior Engineers notified by the Finance Department on dated 27.09.2012 was taken up with the Government to ascertain whether the Grade Pay of Rs. 4800/5400/6600 after regular service of 2 years/10 years/20 years respectively is Carrier Progression Scheme or it is a Category wise/Post Wise re-revision of pay scale.

The Principal Secretary (PW) to the Government of HP informed that the matter was taken up with the Finance Department (Pay Revision) & who has advised as under:-


"The pay structure allowed/granted to Junior Engineers vide letter dated 27.09.2012 after regular service of 2/10/20 years allowing Grade Pay of Rs. 4800/5400/6600 respectively w.e.f 01.10.2012 is a part of "Himachal Pradesh Civil Services (Category/Post wise Revised Pay) Rules, 2012". Under condition No. (ii) of the letter ibid (i.e. 27.09.2012), it was specifically mentioned that fixation of pay in each case will be done according to Rule-5 of HP Civil Services (Category/Post wise Revised Pay Rules, 2012)"

It is further informed that the Carrier Progression Scheme in respect of category of Junior Engineers in State of HP was restored w.e.f 27.08.2009 vide FD. Notification No. FIN(PR)\_B(7)-59/2010 dated 09.08.2012.

In view of above, you are requested to process the cases of pay revision of Junior Engineers in the revised pay HPCS Rules 2022 in light of the above clarification.
