Kindly refer to this office letter No.CWP NO. 6631/2014-112-211 dated 6.04.2016 on the subject cited above,whereby you were requested to comply with the order passed by the Hon'ble High Court by involving all the officer/officials working under your control from the Sub-Divisions level for indentifying the spots where stray cattle are having shelter probably on rain shelters,Bridges, and on roads maintained by the Public Works Department.Thereafter inform the Animal Husbandry Official,representative of Gram Panchyat ward member to make arrangement for shelter and carry these animals to newly constructed nearest gosadans in the depamental vehicles without causing any injury to make your road free from stray cattle to avoid injury to animals as well as to the motorist. But requisite consolidated information Division-wise/Circle-wise relating to your Division office, Circle Office and Zonal office is still awaited.

It has been observed that some Executive Engineers have also sent information to concerned Superintending Engineer with copy endorsed to this office, but respective S.E office have not sent each Division-wise consolidated information on the prescribed proforma to their respective Zonal office uptill now.As such being time bound Hon'ble High Court P.I.L matter in

which consolidated compliance affidavit is to be filed on behalf of Chief Secretary to the Govt of H.P. before 13.06.2016.

You are, therefore, requested to send consolidated information of Division, Circle and then Zone with regard to transportation of the stray animals to the nearest Gosadans and intimation thereof to nearest panchayat headquarter and removal of stray cattle (s) from road on the prescribed proforma already supplied to your office vide this office letter NO. PW-LC-CWP No.6631/2014-10204-303 dated 15.01.2015 on or before 28.05.2016 so that the same could be sent to Govt. of H.P. Hence personal intervention is highly solicited please.
