Whereas, M/s Varnag Banasari Infra Construction Pvt. Ltd., Village Hathithan, PO Bhunter, Tehsil & Distt. Kullu (HP) was registered as class A contractor with the department vide Memorandum No. 18589-18613 dated 03.03.2022 and his enlistment is valid up to 31.03.2026.

AND whereas, Sh. Nitin Kumar Director of M/s Varnag Banasari Infra Construction Pvt. Ltd. prepared and submitted affidavit for the use of hot mix plant etc. to M/s Durga Prashad Construction and another affidavit for the use of six goods carrier vehicles was prepared in the name of Ashwani Kumar but was signed by the same person i.e. Sh. Nitin Kumar who is the Director of M/s Varnag Banasari Infra Construction Pvt. Ltd. M/s Durga Prashad Construction participated in the bids for the work Up-gradation of Patlikuhall Hallan-II road Km.0/000 to 9/465 (Package No.HP-06-996) and Up-gradation of Fozal Neri Kathi Kukri road Km.0/00 to 6/400 (Package No.HP-06-120). M/s Varnag Banasari Infra Construction Pvt. Ltd. participated in the bids for the work Up-gradation of Fozal Neri Kathi Kukri road Km.0/00 to 6/400 (Package No.HP-06-120), Up-gradation of Chhaki to hallan road Km.0/0 to 9/595 (Package No.HP-06-151) and Up-gradation of Manali to Burwa road Km 0/0 to 8/430 (Package No.HP-06-256).

AND whereas while conducting the technical evaluation the committee headed by SE Kullu declared M/s Durga Prashad Construction as non responsive in both the aforesaid bids because he had uploaded aforesaid fake documents, declared M/s Varnag Banasari Infra Construction Pvt. Ltd as non responsive for the work Up-gradation of Fozal Neri Kathi Kukri road Km.0/00 to 6/400 (Package No.HP-06-120 with the reason that he had prepared and submitted fake affidavit to other bidder named as M/s Durga Prashad Construction for helping him to qualifying in the technical bid, but declared M/s Varnag Banasari Infra Construction Pvt. Ltd as responsive for the work Up-gradation of Chhaki to hallan road Km.0/0 to 9/595 (Package No.HP-06-151) and Up-gradation of Manali to Burwa road Km 0/0 to 8/430 (Package No.HP-06-256). The technical evaluations were uploaded on the website by the office of Superintending Engineer 6th circle HPPWD Kullu on 13-12-2022 and as per the SBD, five working days period was given to the bidders to submit any complaint against the technical evaluation. But none of the bidders submitted any complaint. The tender for the work Up-gradation of Chhaki to hallan road Km.0/0 to 9/595 (Package No.HP-06-151) has been cancelled by this office vide letter No. 13501 dated 04-01-2023 and the Superintending Engineer 6th circle HPPWD Kullu has been advised to recall the same.

AND whereas the financial bid of technically responsive bidders were opened on 19.12.2022 and financial evaluation was held on 28.12.2022 and financial evaluations were uploaded on website on 30.12.2022. Within five working days M/s Gorsi Construction vide his letter No. 304-305 dated 04.01.2023 and letter No. 306-307 dated 05.01.2023 again submitted the complaint reproducing the fact that Sh. Nitin Kumar who is the Director of the M/s Varnag Banasari Infra Construction Pvt. Ltd has prepared fake and forged affidavit in favour of M/s Durga Prashad Construction.

AND whereas, the matter was referred to the Enlistment Committee meeting vide letter No. 14422-26 dated 30.01.2023 for consideration and decision against M/S Varnag Banasari Infra Const. Pvt. Ltd and M/s Durga Prashad Construction the Enlistment Committee in its meeting held on 27.02.2023 has recommended that both contractors may be **demoted to lower class i.e. "B" Class.**

Now, therefore, on the recommendation of the Enlistment Committee and in exercise of the powers vested in me vide Rule 23.1 (c), (e) & (j) of the Rules for Enlistment of Contractor in HPPWD 2021, do hereby **demote** M/S Varnag Banasari Infra Const. Pvt. Ltd. Hathithan, Tehsil Bhunter Distt. Kullu (HP) **class "A" contractor to lower class i.e. "B" Class** with immediate effect.
