Sir,

In continuation of this office letter No. PWE-82-1-Apptt.(Comp. Apptt.)/ES-I- 10898-10998 dt. 28.02.2022, I am directed to inform that Finance department Govt. of H.P. vide O.M.No.Fin-F-(A)-16-1/2013-I dated 08.08.2022 has decided to extend the instructions regarding relaxation in 5 per cent quota in respect of Class-IV post for granting appointment on compassionate grounds issued by the Govt., vide Notification dt. 24.01.2022 (para I to IV) till 31.08.2022 (Copy available on the departmental website WWW.himachal.nic.in/finance under the link "Expenditure").

There are 39 approved applications (List enclosed) in Class-III in the department to be considered for appointment in Class-III as per seniority and availability of vacancy under 5% quota. Whereas the vacancies of the year 2022 under 5 per cent quota in class-III shall be reckoned on or after 31.12.2022 and number of candidates will be considered for appointment equivalent to the vacancies arise under 5 per cent quota only.

However, in view of the latest notification dated 08.08.2022 of the state Govt. the desirous candidate(s) (amongst the annexed list) may also apply for the post of Peon/Chowkidar & submit their application/undertaking through their controlling officer direct to this office upto 25/08/2022. The options received after 25/08/2022 shall not be entertained. The option so made by the applicant shall be treated as final and any subsequent change shall not be allowed.

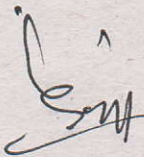
