2. Timely receipt of requisitions will enable the Commission to craft a thoughtful schedule, considering all these factors and cater to the needs of youth from every corner of the State, instilling in them a sense of confidence and inclusivity, reassuring them that their needs matter.

3. After considering the matter, the State Government has decided to establish a deadline for all administrative departments etc. to forward their annual requisitions, including vacancies that will arise during the year, December 31st is designated as the deadline for departments to submit their requisitions. The Commission will then finalize and publish the schedule by January 15th of every year. The requisitions received after 31st December shall be carried forward to subsequent year, meaning thereby that these have to wait for one clear year to get advertised. Upon receiving the requisitions, the Commission will create a schedule, taking into account factors such as the type of exam (1, 2, or 3 tier), number of vacancies, and expected number of candidates. For instance, the Commission prefers to schedule popular exams like HPAS in April/May, when all parts of the state are accessible, and examination centers can be set up in every district, facilitating easy access for candidates. With this practice while youths will be aware of yearly schedule well in advance to practice and the supporting department such as police and District administration will be able to allot/ use resources most efficiently.

4. The above decision of the Government may be adhered to seriously to the specified timelines.
