Sir,

I am directed to refer to the subject cited above and to say that it has been come to the notice that some Government employees are making direct correspondence with the higher authorities or the Government without routing such communication through proper channel which is in contravention of the provisions of the Central Civil Services (Conduct) Rules, 1964, Central Civil Services (Classification, Control and Appeal) Rules, 1965 and the relevant instructions contained in the Govt. of Himachal Pradesh Office Manual, 2011.

In this regard, attention is invited to Rule 3(1)(iii) of the CCS (Conduct) Rules, 1964 which provide that **the Government servant will do nothing which is unbecoming of a Government servant** and para 8.5.1 of Govt. of HP Office Manual, 2011 also provides that **no member of the Department shall submit any letter / representation / request directly to the Governor / Chief Minister / Minister / Chief Secretary / Secretary / Special Secretary / Additional Secretary / Joint Secretary / Deputy Secretary / Under Secretary or Head of the Department / Office.**

Rule 11 of CCS (Conduct) Rules, 1964 further provides that **no Government servant shall, except in accordance with any general or special order of the Government or in the performance in good faith of the duties assigned to him, communicate, directly or indirectly, any official document or any part thereof or information to any Government servant or any other**

person to whom he is not authorized to communicate such document or information.

Further, Rule 20 of CCS (Conduct) Rules, 1964 also provides that **no Government servant shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further their interests in respect of matters pertaining to their service under the Government.** Moreover, Rule 3 of CCS (Conduct) Rules, 1964 provides that **every Government servant is expected to maintain absolute integrity and discipline in official dealings, which includes adhering to prescribed channels of communication.** The CCC (CCA) Rules, 1965 also empower the Disciplinary Authorities to take appropriate action against employees who are found guilty of misconduct, including violation of procedural discipline and insubordination.

In view of above, you are, therefore, requested to bring these instructions to the notice of all concerned officers / officials under your control to adhere to these instructions in letter & spirit, under intimation to this department. Any violation of these instructions shall be treated as misconduct and may invite disciplinary action as per the extant rules and instructions.

This may be treated as most urgent.
