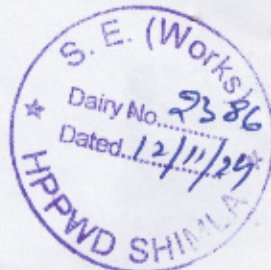
It has come to the notice of the Government on multiple occasions that photographs of the Hon'ble Chief Minister taken during departmental meetings and public functions are being released without prior approval to the media by the concerned Departments. In some cases, these photographs portray inappropriate gestures and could potentially harm the public image of the Hon'ble Chief Minister. This unregulated dissemination of photographs can have far-reaching consequences, which may affect the image and perception of the Hon'ble Chief Minister as well as of the Government.

In view of the above, it has been decided by the Government that no photographs of the Hon'ble Chief Minister taken during departmental meetings, official engagements, or public functions shall be released by any department or government agency without prior approval of the Director, Information and Public Relations or photographs released by Director, Information and Public Relations only be released to the media.

It is requested to kindly ensure that these instructions are communicated to all relevant officers and personnel within your department for strict adherence.
