"Additional pleadings in terms of order dated 24.10.2024 even though are stated to be filed, however, the same are lying under objection. The State is directed to remove objection and re-file the same within a week.


We are informed at the Bar that the outsource employees are being recruited by the agencies/companies so identified by the H.P. State Electronics Corporation. The requisition is sent to these agencies/companies by the different departments for providing requisite human resource on out-source basis. The concerned company/agency invites the applications from the prospective candidates and the final selection is made as per the criteria so mentioned in the advertisement

There is no fair and transparent manner in which the names of such candidates are being sponsored. Henceforth, it is directed that the names of the candidates seeking employment shall be displayed on the official website of the sponsoring agencies as well as the H.P. State Electronic Corporation as per seniority i.e. "first come first serve". Till then no appointment on outsource basis shall be made.
