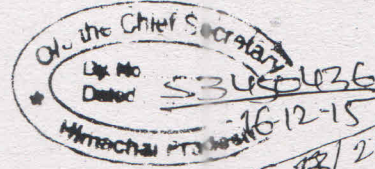

Ministry vide letter of even number dated 16<sup>th</sup> September, 2013 has circulated Standard RFP document for selection of Authority's Engineer for works to be implemented on Engineering Procurement and Construction (EPC) mode. Certain modifications were made in the Standard RFP document vide letter of even number dated 11<sup>th</sup> December, 2014.

2. The existing provision of assigning weightage to firms for permanent employment of key personnel made in the RFP clause 3.3 (ii) and clause 5.2 have been reviewed in the Ministry and it is decided that the contents of clause 3.3 (ii) should be modified to delete the sentence "a retainer will be getting only 85% weightage".
