Their enlistment would be valid up to **31.3.2021** after which if so desired by them they will have to seek renewal of registration on the prescribed application form along with requisite renewal fee to be deposited with this department. The enlistment would be renewed further subject to conditions given in Rules for enlistment and revalidation of Enlistment in HPPWD, 2015. Failure to fulfill the conditions may at the time of renewal make them liable to the denial of renewal. Further in case their performance is not found to be satisfactory as contractor their enlistment can be cancelled.

They shall apply for renewal at least three months before the expiry of their enlistment. They shall be required to deposit earnest money with each tender or as may be amended from time to time.

They shall apply to the Income Tax officer of the area in which they are assessed for obtaining income tax clearance certificate. Such certificate shall be submitted to this office\EE concerned by the end of June every year. Failure to submit income tax clearance certificate shall make them liable to be removed from the approved list of the contractors in the department.

They shall promptly intimate any subsequent change in their postal address. Acquiring or disposal of any immovable property belonging to them be immediately intimated failing which their enlistment is liable to be cancelled.

They are bound to comply with all the above conditions. In case they fail to execute the works allotted to them, they will render themselves liable to face penalties or even the eventuality of getting blacklisted. Before issuing the tender form to the contractors it may be ensured by Executive Engineer that they have TIN & PAN available.
