Enlistment of Contractor.

Sir,

In continuation to this Department notification of even No. dated 26-05-2016 on the subject cited above, I am directed to say that as per Rule 8.1, "Contractor enlisted in a particular class shall be eligible to tender for his own class or an one step below". These rules hamper in work of periodical renewal of bituminous and leading to delay in laying bitumen. This matter alongwith power of awarding of single tender has been examined at Govt. level and decides as under:-

*17/5/16*

1. For periodical renewal and involved laying of bitumen, any class of higher category contractors can participate subject to requirement of T&P and machinery requirement as per enlistment rules.
2. Single tenders for periodical renewal may be allowed to be awarded by one step higher authority, if the tendered amount is within the sanctioned amount of estimate.

You are, therefore, requested to take necessary action accordingly and upload the same in PWD website.
