Regarding compliance of the directions passed by Hon'ble High Court.

It is being noticed by this office that the various Court matters (specifically the Execution Petition(s) & Contempt Petition(s)) are relating to different zones are being listed before the Hon'ble High Court frequently. The service matters pertaining the issue of Pension , Regularization and Seniority of Class-III & Class-IV workmen are very common, which are being listed before the Hon'ble High Court. In some of the cases, the concerned Executive Engineer(s) and the Superintending Engineer(s) have been impleaded as necessary parties by the petitioner(s), and this office is not a party to the petition. The Court orders are being intimated to them directly by the o/o Ld. Advocate General, HP without any intimation to this office. This office is not given any intimation, as a result of which the matters are listed and the undersigned has to appear before the Hon'ble High Court alongwith Principal Secretary (PW) very frequently. It has been noticed that the field offices are negligent about the directions passed by the Hon'ble High Court as well as the directions issued from this office and as result thereof the officers are being directed to appear in person before the Hon'ble High Court. It has also been noticed that the appeal against the judgments are being filed after delay of many months and in some cases,

the delay is of many years. Such approach of official is not acceptable and cause lots of embarrassment to officers of department and also comes adverse impact on state exchequer.

In view of the above position, you are, therefore, requested to kindly issue strict directions to all the Executive Engineer(s) working under your jurisdiction to review the pendency of their Court matters on day to day basis. Further you are requested to kindly appoint **a Nodal Officer(Supdt. Gr. II) in your office(s) who will check the daily Cause List on official website of Hon'ble High Court with the assistance of your zonal Legal Cell and thereafter maintain the Compliance Register of Court matters and intimate the list of cases listed one day in advance by 4:00 PM** on the prescribed format either through E-mail or FAX:-


