All the above zones and circle have already been provided with tablets for online monitoring of Road Accident Data Management System (RADMS) data on road accidents. The nodal officers designated above in addition to their duties shall be responsible for:-

1. Monitoring the accident data in the RADMS to identify location on roads which have safety issues.
2. Identifying the spots where accident factors are related to road infrastructure.
3. Liaisoning with Divisional Executive Engineers for suggesting and implementing counter measures/rectifications through Engineering intervention on these spots.
4. Submitting monthly progress report on account of above to Superintending Engineer (P&M) Cum Chairman Road Safety Cell HP.PWD Headquarter Nirman Bhawan Nigam Vihar Shimla-2 through e-mail.

It is further brought to the notice of all concerned that the above officers have been designated as Nodal Officer (Road Safety) on behalf of their Head of Offices and therefore their merely being designated as NO(Road Safety) does not in any way absolve their Head of Offices from discharging their responsibilities in this regard. Further Hon'ble Supreme Court has constituted a Supreme Court Committee on Road Safety for regular monitoring of Road Safety issues, therefore due attention is required to be given in this regard.
